ROAD TRAFFIC

The M69 and M6 Motorways (South of Hinckley) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 21st March 2014

Coming into force - - 28th March 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the M69 Motorway ("the M69"), the M6 Motorway ("the M6") and connecting roads, is satisfied that traffic on a length of one of those roads and some of those connecting roads, in the Counties of Warwickshire and Leicestershire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the M69 and M6 Motorways (South of Hinckley) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Friday 28th March 2014.

2. In this Order:

"the motorway"

means the -

- a) northbound carriageway of the M69 from its junction with the slip road leading to the A46 (M6 Junction 2), to its junction with the slip road leading to the roundabout junction at M69 Junction 1; and
- b) southbound carriageway of the M69 from its junction with the slip road leading from the M69 at Junction 1, to its junction with the slip road leading from the A46 (M6 Junction 2);

"a slip road"

means the slip roads leading -

- a) from the northbound carriageway of the M69 at Junction 1; and
- b) to the southbound carriageway of the M69 at Junction 1.

"a link road"

means the link roads leading -

a) from the southbound carriageway of the M6 to the northbound carriageway of the M69 (M6 Junction 2):

- b) from the B4065 Hinckley Road to the link road leading from the southbound carriageway of the M6 to the northbound carriageway of the M69 (M6 Junction 2);
- c) from the southbound carriageway of the M69 to the roundabout junction with the A46, A4600/B4065 Hinckley Road (M6 Junction 2);

"the works period"

means the period starting at 20:00 hours on Friday 4th April 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the motorway, a slip road or a link road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle
 - (i) being used for police, fire brigade or ambulance purposes;
 - (ii) proceeding at the direction of, or with the permission of, a police constable, or traffic officer in uniform; or
 - (iii) being used in connection with the said works.
