# The A595 Trunk Road (Egremont) (40 Miles Per Hour Speed Limit) Order 2014

 Made
 - - - - - - 3rd April 2014

 Coming into force
 - - 14th April 2014

The Secretary of State for Transport in exercise of the powers conferred by sections 84(1)(a) and (2) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order on the A595 Trunk Road in the District of Copeland in the County of Cumbria:

1. This Order may be cited as The A595 Trunk Road (Egremont) (40 Miles Per Hour Speed Limit) Order 2014 and shall come into force on 14th April 2014.

#### 2. In this Order:

"the trunk road' means the A595 Trunk Road from a point 12 metres northwest of the point where the A595 Trunk Road joins the south eastern side of the circulatory carriageway of the A595/A5086/ Howbank Road Roundabout (Clintz Roundabout) in a south easterly direction to a point 11 metres northwest of the point where the A595 Trunk Road joins the south eastern side of the circulatory carriageway of the Main Street/East Road Roundabout (East Road Roundabout);

"the circulatory carriageway" means the circulatory carriageway of the A595/A5086/Howbank Road Roundabout (Clintz Roundabout).

- 3. Subject as mentioned in articles 5 and 6 of this Order, no person shall cause or permit any motor vehicle to be driven at a speed exceeding 40 miles per hour in the trunk road or the circulatory carriageway.
- 4. Subject as mentioned in articles 5 and 6 of this Order, no person shall cause or permit any motor vehicle to be driven at a speed exceeding 40 miles per hour in the access road to Egremont Cemetery (North Road).
- 5. Nothing in articles 3 and 4 of this Order shall apply to any vehicle being used for emergency purposes by the police, fire and rescue or ambulance services.
