ROAD TRAFFIC

The A49 Trunk Road (Hereford, Herefordshire) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 28th April 2014
Coming into force - - 5th May 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A49 Trunk Road (“the A49”), is satisfied that traffic on a length of that road, in the County of Herefordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A49 Trunk Road (Hereford, Herefordshire) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 5th May 2014.

2. In this Order –

“the trunk road” means the northbound and southbound carriageway of the A49 between its junction with Barton Road and its roundabout junction with Edgar Street and the A438 Newmarket Street;

“central reservation” means that part of the trunk road which separates its carriageways for the safety and guidance of vehicular traffic using that road;

"the works period" means the period starting at 22:15 hours on Monday 12th May 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the trunk road.

4. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or leave the trunk road at its junction with any side road.

5. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed through the gap in the central reservation of the trunk road adjacent to the A438 Eign Street.

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

7. The provisions of articles 3 and 4 shall not apply to any vehicle;

- a) being used for police, fire brigade or ambulance purposes;
- b) proceeding at the direction of, or with the permission of, a police constable;
- c) being used in connection with the said works; or
- d) proceeding to and from premises which are accessible from, and only from, the trunk road.
