ROAD TRAFFIC

The A50 Trunk Road (Caverswall, Staffordshire) (Temporary Prohibition of Traffic) Order 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50") and connecting roads is satisfied that traffic on a length of that road and some of those connecting roads, at Caverswall in the County of Staffordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A50 Trunk Road (Caverswall, Staffordshire) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 5th May 2014.

2. In this Order:

"the trunk road"	means the westbound carriageway of the A50 from its junction with the slip road leading to the B5029 Grindley Lane roundabout, to its junction with the slip road leading from the A520 Sandon Road/Weston Road roundabout;
"a slip road"	 means the slip roads leading – a) to the westbound carriageway of the A50 from its roundabout junction with the B5029 Grindley Lane; b) from the westbound carriageway of the A50 to its roundabout junction with the A521 Uttoxeter Road and Lysander Road; c) to the westbound carriageway of the A50 from its roundabout junction with the A521 Uttoxeter Road and Lysander Road;

	 d) from the westbound carriageway of the A50 to its roundabout junction with the A520 Sandon Road/Weston Road;
"the works period"	means the period starting at 21:00 hours on Monday 12th May 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle-

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable; or
- (c) being used in connection with the said works.
