The A483 Trunk Road (Llanymynech to Mile End, Oswestry, Shropshire) (Temporary Prohibition of Traffic) Order 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A483 Trunk Road ("the A483"), is satisfied that traffic on a length of that road between Llanymynech and Mile End near Oswestry in the County of Shropshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(**a**), hereby makes the following Order:-

1. This Order may be cited as the A483 Trunk Road (Llanymynech to Mile End, Oswestry, Shropshire) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Tuesday 13th May 2014.

2. In this Order –

"the trunk road"	means the northbound and southbound carriageway of the A483 from its roundabout junction with the A5, B4579 Shrewsbury Road and the access and egress roads to the service area known as Mile End Roundabout, to the Welsh border;
"the works period"	means the period starting at 20:00 hours on Wednesday 14th May 2014 and ending when the said works have

been completed;

3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the trunk road.

4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or leave the trunk road at its junction with -

- i. the unnamed road leading to Hazel Grove, situated 452 metres south of the B5069; and
- ii. the unnamed road leading to Albridge Lane, situated 559 metres south of the B5069; and
- iii. Church Lane, leading to the parish church of Saint Philip and Saint James; and
- iv. A495 and B4396 (Llynclys Junction); and
- v. Penygarreg Lane; and
- vi. Station Road (north); and
- vii. Station Road (south); and
- viii. Briggs Lane; and
 - ix. Stargarreg Lane; or
 - x. Rhew Level Lane;

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable;
- (c) being used in connection with the said works; or
- (d) proceeding to and from premises which are accessible from, and only from, the trunk road
