ROAD TRAFFIC

The M62 Motorway (Langham Interchange) (Temporary Restriction and Prohibition of Traffic) Order 2014

Made - - - - 23rd January 2014

Coming into force - - 2nd February 2014

WHEREAS, the Secretary of State for Transport, being the traffic authority for the M62 Motorway, the M18 Motorway and connecting roads, in the County of the East Riding of Yorkshire, is satisfied that traffic on those Motorways and one of those connecting roads should be restricted and prohibited because bridge repairs and safety maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

1. This Order may be cited as the M62 Motorway (Langham Interchange) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on 2nd February 2014.

2. In this Order:-

"the M62" means the M62 Motorway;

"the M18" means the M18 Motorway;

"the link road" means the link road connecting the M18 northbound carriageway with the M62 eastbound carriageway;

"the carriageway" means the M18 northbound carriageway from a point 1750 metres south of the centreline of the Langham East Bridge to a point 1200 metres north of that bridge, on the M62 eastbound carriageway, a distance of 2950 metres;

"the first works period" means a period starting at 00:01 hours on Monday 3rd February 2014 and ending when the said works have been completed;

"the second works period" means a period of 10 hours starting at 20:00 hours on Monday 3rd February 2014 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5 no person shall, during the first works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour in the carriageway.
- **4.** Subject as mentioned in article 5 no person shall, during the second works period, cause or permit any vehicle to enter or proceed in the link road.

- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in article 4 shall apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to any vehicle being used for a purpose specified in paragraph (a) of this article.

and nothing in article 4 shall apply to any vehicle proceeding in the M18 and M62 to or from premises and property which is accessible for that vehicle from, and only from, that road.

6. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
