ROAD TRAFFIC

The M4 Motorway (Junctions 10 - 11) (No 2) (Temporary Restriction and Prohibition of Traffic) Order 2014

 Made
 9th June 2014

 Coming into force
 28th June 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the M4 Motorway and connecting roads, is satisfied that traffic should be restricted and prohibited on a length of that motorway and prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and paragraph 27(1) of schedule 9 to, the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M4 Motorway (Junctions 10 - 11) (No 2) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on 28th June 2014.

2. In this Order:

"the motorway" means the M4 Motorway in the District of Wokingham, the Borough of Reading and the District of West Berkshire;

"the length of motorway" means both carriageways of the motorway between the B3018 (The Straight Mile) overbridge, east of Junction 10 (A329(M)) and a point 600 metres west of the River Loddon underbridge, east of Junction 11 (A33/B3270);

"the Regulations" means the regulation 16(2) of the Motorways Traffic (England and Wales) Regulations 1982(**b**);

"the westbound carriageway" and "the eastbound carriageway" mean, respectively, the westbound carriageway and the eastbound carriageway of the length of motorway;

"a hard shoulder" means the hard shoulder, within the meaning of regulation 3(1)(e) of the Regulations, which is adjacent to the westbound carriageway or the eastbound carriageway;

"recovery vehicle" has the meaning given in paragraph 5 of Schedule 1 to the Vehicle Excise and Regulation Act 1994(**c**);

"overall width" has the meaning given in regulation 3(2) of the Road Vehicles (Construction and Use) Regulation $1986(\mathbf{d})$;

"abnormal load" means a vehicle having an overall width exceeding 9 feet 6 inches;

"specified signs" means -

- signs of the type, colour and size shown in diagram 7103 in part 11 of Schedule 12 to the Traffic Signs Regulations and General Directions 2002(a) which comply with the provisions of regulation 56 of those Regulations, or
- (ii) traffic signs, consisting of temporary vertical safety barriers of a character authorised by the Secretary of State under section 64 of the Road Traffic Regulation Act 1984;

"a link road" means -

- (i) the road leading from the eastbound carriageway of the motorway to the northbound carriageway of the A329(M) at Junction 10,
- (ii) the road leading from the eastbound carriageway of the motorway to the southbound carriageway of the A329(M) at Junction 10,
- (iii) the road leading from the northbound carriageway of the A329(M) to the westbound carriageway of the motorway at Junction 10,
- (iv) the road leading from the northbound carriageway of the A329(M) to the eastbound carriageway of the motorway at Junction 10,
- (v) the road leading from the southbound carriageway of the A329(M) to the westbound carriageway of the motorway at Junction 10,
- (vi) the road leading from the southbound carriageway of the A329(M) to the eastbound carriageway of the motorway at Junction 10,
- (vii) the road leading from the westbound carriageway of the motorway to the northbound carriageway of the A329(M) at Junction 10, or
- (viii) the road leading from the westbound carriageway of the motorway to the southbound carriageway of the A329(M) at Junction 10;

"a first works period" means a period of 24 hours starting at 0001 hours on Monday 30th June 2014 or on any subsequent day until 27th December 2015;

"a second works period" means a period of 8 hours starting at 2200 hours on Monday 30th June 2014 or on any subsequent day until 27th December 2015;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- 3. Subject as mentioned in articles 5, 6 and 8, no person shall, during
 - (a) a first works period, cause or permit any vehicle to enter or proceed in the westbound carriageway or the eastbound carriageway; or
 - (b) a second works period, cause or permit any vehicle to enter or proceed in a link road.
- **4.** Subject as mentioned in articles 5, 8 and 9(a), no person shall, during a first works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the westbound carriageway, the eastbound carriageway or a hard shoulder.
- **5.** The provisions of articles 3, 4, 6 and 7 shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs.
- $\bf 6.$ (1) During such times as, pursuant to article 5, movement of traffic is prohibited in one or more lanes of the westbound carriageway but is not prohibited in any lane of the eastbound carriageway, no person shall cause or permit any
 - (a) vehicle to enter or proceed in the eastbound carriageway other than in such direction that specified signs are at all times on the right hand or offside of the vehicle; or

[&]quot;works" mean bridge maintenance and all associated work on the motorway;

- (b) vehicle having an overall width exceeding 6 feet 6 inches to enter or proceed in the eastbound carriageway.
- (2) During such times as, pursuant to article 5, movement of traffic is prohibited in one or more lanes of the eastbound carriageway but is not prohibited in any lane of the westbound carriageway, no person shall cause or permit any
 - (a) vehicle to enter or proceed in the westbound carriageway other than in such direction that specified signs are at all times on the right hand or offside of the vehicle; or
 - (b) vehicle having an overall width exceeding 6 feet 6 inches to enter or proceed in the westbound carriageway.
- (3) When pursuant to article 5, movement of traffic is prohibited in one or more lanes in a length of one carriageway but is not prohibited in any lane of the corresponding length of the other carriageway, the provisions of this article with respect to the other carriageway shall apply to that length of that carriageway.
- 7. Subject as mentioned in articles 5, 8 and 9(a), no person shall, during a first works period, cause or permit any vehicle with an overall width exceeding 6 feet 6 inches to enter or proceed in—
 - (a) any lane in a carriageway or length of carriageway, where one or more lanes in that carriageway or length and the hard shoulder adjacent to that carriageway or length are open for use by traffic proceeding in the same direction; or
 - (b) any lane other than the nearside lane of two or more lanes in a carriageway or length of carriageway, where only those lanes are open for use by traffic proceeding in the same direction;

and in this article a reference to a carriageway is a reference to the westbound carriageway or the eastbound carriageway.

- **8.** (1) Nothing in articles 3, 6(1)(b), 6(2)(b) or 7 shall apply to -
 - (a) a recovery vehicle or a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
 - (d) any vehicle being used for winter maintenance purposes.
- (2) Nothing in article 4 shall apply to a vehicle being used for police, ambulance or fire and rescue authority purposes and to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
 - (3) Nothing in articles 6(1)(b), 6(2)(b) or 7 shall apply to an abnormal load.
- **9.** During a first works period, the undermentioned provisions of the Regulations are hereby suspended:
 - (a) regulations 5 and (insofar as it relates to a vehicle being driven) 9, in respect of a hard shoulder, at such times and to such extent as shall from time to time be indicated by traffic signs; and
 - (b) regulation (6)(3), in respect of a vehicle being driven westwards in the eastbound carriageway by virtue of article 6(1)(a), or eastwards in the westbound carriageway by virtue of article 6(2)(a).
 - 10. The M4 Motorway (Junctions 10 11) (Temporary Restriction and Prohibition of Traffic) Order $2014(\mathbf{b})$ is hereby revoked.
