## ROAD TRAFFIC

The M62 Motorway and the A1(M) Motorway (Castleford to Holmfield) (Temporary Prohibition of Traffic) Order 2014

Made - - - 12th June 2014

Coming into force - 22nd June 2014

WHEREAS, the Secretary of State for Transport, being the traffic authority for the M62 Motorway and the A1(M) Motorway and connecting roads, in the District of Wakefield, in the County of West Yorkshire, is satisfied that traffic on those motorways and some of those connecting roads should be prohibited because carriageway resurfacing and associated works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) makes the following Order:

- **1.** This Order may be cited as the M62 Motorway and the A1(M) Motorway (Castleford to Holmfield) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 22nd June 2014.
- **2.** Subject as mentioned in article 3 of this Order, no person shall, during a period of 10 hours starting at 20:00 hours on Monday 23rd June 2014 or any subsequent night thereafter until the said works have been completed, cause or permit any vehicle to enter or proceed in the M62 Motorway:
- (i) eastbound carriageway between the nose of the eastbound exit slip road and the nose of the eastbound entry slip road at Junction 32 (Castleford), a distance of 852 metres;
- (ii) westbound carriageway between the nose of the westbound exit slip road to the nose of the westbound entry slip road at Junction 32, a distance of 1096 metres;
- (iii) eastbound entry and westbound exit slip road at Junction 32;
- (iv) eastbound exit and westbound entry slip road at Junction 32A (Holmfield);
- (v) link road connecting the eastbound carriageway with the A1(M) Motorway northbound carriageway at Holmfield (M62 Motorway Junction 32A and A1(M) Motorway Junction 41);
- (vi) link road connecting the eastbound carriageway with the A1(M) Motorway southbound carriageway at Holmfield;
- (vii) link road connecting the westbound carriageway with the A1(M) Motorway northbound carriageway at Holmfield;
- (viii)link road connecting the westbound carriageway with the A1(M) Motorway southbound carriageway at Holmfield; and
- (ix) westbound carriageway from the nose of the link road connecting the M62 Motorway westbound carriageway with the A1(M) Motorway northbound carriageway to the nose

of the link road connecting the M62 Motorway westbound carriageway with the A1(M) Motorway southbound carriageway at Holmfield, a distance of 1100 metres.

- **3.** The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
  - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
  - (b) a vehicle being used for, or in connection with, the said works, or for traffic officer purposes; or
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
