ROAD TRAFFIC

The M11 Motorway (Junctions 7 to 11) and the A11 Trunk Road (Stumps Cross, Pampisford and Waterhall Interchange) Connecting Roads (Temporary Prohibition of Traffic) Order 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the M11 Motorway ("the M11") and the A11 Trunk Road ("the A11") and connecting roads, is satisfied that traffic on some of those connecting roads, in the Counties of Cambridgeshire and Suffolk, should be prohibited because of the likelihood of danger to the public due to a special event being held on the local authority roads:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(b) of the Road Traffic Regulation Act $1984(\mathbf{a})$, hereby makes the following Order:-

1. This Order may be cited as the M11 Motorway (Junctions 7 to 11) and the A11 Trunk Road (Stumps Cross, Pampisford and Waterhall Interchange) Connecting Roads (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 30th June 2014.

2. In this Order –

"a connecting road" means the -

- (a) exit slip roads leading from the northbound and southbound carriageways of the M11 at Junction 7,
- (b) exit slip road leading from the northbound carriageway of the M11 at Junction 9a,
- (c) exit slip roads leading from the northbound and southbound carriageways of the M11 at Junction 10,
- (d) exit slip roads leading from the northbound and southbound carriageways of the M11 at Junction 11,
- (e) exit slip road leading from the southbound carriageway of the A11 to the A1301 Stumps Cross,
- (f) exit slip road leading from the southbound carriageway of the A11 to the A505 Causeway at Pampisford, and
- (g) road that links the southbound carriageway of the A11 to the A1304 from its diverge point with the A14 at Junction 38 Waterhall Interchange.

3. Subject as mentioned in article 4 no person shall cause or permit any vehicle to enter or proceed in a connecting road during the period starting at 05:00 hours on Monday 7th July 2014 and ending at 18:00 hours when the said likelihood of danger has ceased.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to a vehicle being used for police, fire and rescue authority, ambulance or traffic officer purposes.
