# **IMMIGRATION**

The Immigration (Designation of Travel Bans) (Amendment) Order 2014

Made - - - - 14th July 2014
Laid before Parliament 16th July 2014
Coming into force - - 21st July 2014

The Secretary of State makes the following Order in exercise of the power conferred by section 8B(5) of the Immigration Act 1971(1).

- 1. This Order may be cited as the Immigration (Designation of Travel Bans) (Amendment) Order 2014 and comes into force on 21st July 2014.
- **2.** For the Schedule to the Immigration (Designation of Travel Bans) Order 2000(**2**) substitute the Schedule set out in Schedule 1 to this Order.
  - 3. The instruments listed in Schedule 2 to this Order are revoked.
