## ROAD TRAFFIC

# The M25 Motorway (Junction 12) (M3 Junction 2 Slip Road) (Temporary Prohibition of Traffic) Order 2014

 Made
 30th June 2014

 Coming into force
 19th July 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the M25 and M3 Motorways and connecting roads, is satisfied that traffic should be restricted and prohibited on lengths of that road and connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the M25 Motorway (Junction 12) (M3 Junction 2 Slip Road) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 19th July 2014.

#### 2. In this Order:

"the M25" means the M25 motorway in the Counties of Surrey and Berkshire;

"the slip road" means the road leading from the anti-clockwise carriageway of the M25 at Junction 12;

"works" means carriageway resurfacing, loop replacement, traffic sign installation, inspections and associated works; and

"a works period" means a period of –

- (i) 7 hours starting at 2300 hours on Friday 25th July 2014 or on any subsequent Friday,
- (ii) 8 hours starting at 2200 hours on Saturday 26th July 2014 or on any subsequent Saturday, or
- (iii) 7 hours starting at 2230 hours on Sunday 27th July 2014 or on any subsequent Sunday,
- (iv) 7½ hours starting at 2200 hours on Monday 28th July 2014 or on any subsequent day other than a Friday, Saturday or Sunday,

until 18th January 2016.

**3.** Subject as mentioned in article 4 below, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the slip road.

- **4.** The provisions of articles 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs.
  - 5. (1) Nothing in article 3 above shall apply to -
    - (a) a vehicle being used in connection with the said works;
    - (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
    - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
    - (d) any vehicle being used for winter maintenance purposes.
