## ROAD TRAFFIC

The A1 and the A46 Trunk Roads (Winthorpe to Harlaxton) (Temporary Restriction and Prohibition of Traffic) Order 2014

Made - - - - 28th July 2014

Coming into force - - 4th August 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A1 Trunk Road ("the A1") and the A46 Trunk Road ("the A46") and the connecting roads, is satisfied that traffic on lengths of those trunk roads and some of those connecting roads, between Winthorpe and Harlaxton in the Counties of Nottinghamshire and Lincolnshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A1 and the A46 Trunk Roads (Winthorpe to Harlaxton) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on Monday 4th August 2014.

2. In this Order -

"Winthorpe Roundabout" means the circulatory carriageway of the roundabout

junction of the A46, A1133 and Drove Lane,

Winthorpe;

"the A46 Eastern Roundabout" means the circulatory carriageway of the roundabout

junction of the A46, A17 and the slip roads leading to and from the southbound carriageway of the A1,

Winthorpe;

"the A46 Western Roundabout" means the circulatory carriageway of the roundabout

junction of the A46, B6166 and the slip roads leading to and from the northbound carriageway of the A1,

Newark-On-Trent:

"Swingbridge Road Roundabout"

means the circulatory carriageway of the roundabout junction of Swingbridge Road, the slip roads leading to and from the southbound carriageway of the A1 and the link road leading to and from the A607 Harlaxton Road, Grantham;

"the first length of trunk road"

means the southbound carriageway of the A1 from a point 1500 metres north west of the centreline of the A46 overbridge at Winthorpe, to a point 100 metres south of the centrepoint of the A607 Harlaxton Road underbridge, Grantham;

"the second length of trunk road"

means the southbound carriageway of the A46 from its junction with the Winthorpe Roundabout, to its junction with the A46 Eastern Roundabout, including that roundabout:

"the third length of trunk road"

means the northbound carriageway of the A1 from a point 340 metres south of the Dysart Road overbridge, Grantham, to a point 500 metres northwest of the centreline of the A46 overbridge at Winthorpe;

"the fourth length of trunk road"

means the southbound carriageway of the A1 from its junction with the slip road leading to the A46 Eastern Roundabout, to its junction with the slip road leading from Swingbridge Road Roundabout;

"the fifth length of trunk road"

means the northbound carriageway of the A1 from its junction with the slip road leading to its roundabout junction with the A607 near Harlaxton, to its junction with the slip road leading from the A46 Western Roundabout:

"central reservation"

means that part of the trunk road which separates its carriageways for the safety and guidance of vehicular traffic using that road;

"layby"

means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(a) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

"footway"

means a way comprised in a highway which also comprises a carriageway, being a way over which the public have a right of way on foot only; "the works period"

means the period starting at 00:01 hours on Monday 11th August 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 9 and 10, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the first length of trunk road, the second length of trunk road, the third length of trunk road, or any slip road leading to or from the first length of trunk road or the third length of trunk road.
- **4.** Subject as mentioned in articles 9 and 10, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the fourth length of trunk road, the fifth length of trunk road or any slip road leading to or from the fourth length of trunk road or the fifth length of trunk road.
- **5.** Subject as mentioned in articles 9 and 10, no person shall, during the works period, cause or permit any vehicle to enter or proceed through any gap in the central reservation adjacent to the fourth length of trunk road and the fifth length of trunk road.
- **6.** Subject as mentioned in articles 9 and 10, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any layby situated adjacent to the fourth length of trunk road or the fifth length of trunk road;
- **7.** Subject as mentioned in articles 9 and 10, no person shall, during the works period, cause or permit any vehicle to enter or leave the fourth length of trunk road or the fifth length of trunk road at its junction with any side road.
- **8**. Subject as mentioned in articles 9 and 10, no person shall, during the works period, cause or permit any pedestrian to enter or proceed in the footway adjacent to the fourth length of trunk, the fifth length of trunk road, or any slip road leading to and from the fourth length of trunk road or the fifth length of trunk road.
- **9.** The provisions of articles 3 to 8 inclusive shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- **10.** The provisions of
  - (a) articles 3 to 7 inclusive shall not apply to any vehicle -
    - (i) being used for police, fire brigade or ambulance purposes; or
    - (ii) proceeding at the direction of, or with the permission of, a police constable;
  - (b) article 3 shall not apply to any vehicle being used for special forces purposes;
  - (c) article 4 shall not apply to any vehicle proceeding to and from premises which are accessible from, and only from, the trunk road;
  - (d) articles 4 to 7 inclusive shall not apply to any vehicle being used in connection with the said works; and

- (e) article 8 shall not apply to any person –

  (i) engaged in police, fire brigade or ambulance activity; or

  (ii) engaged in activity connected with the works.
