ROAD TRAFFIC

The M25 Motorway and the A30 Trunk Road (Junction 13 Slip Road and A30 Link Road) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 18th August 2014

Coming into force - - 6th September 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the M25 Motorway, A30 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M25 Motorway and the A30 Trunk Road (Junction 13 Slip Road and A30 Link Road) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 6th September 2014.

2. In this Order:

"the motorway" means the M25 Motorway in the County of Surrey;

"the trunk road" means the A30 Trunk Road in the County of Surrey;

"the slip road" means the road leading from the anti-clockwise carriageway of the motorway at Junction 13 (A30/B376);

"the link road" means the length of trunk road leading from the Runnymede Roundabout to the point where the link road merges with the exit slip road from the clockwise carriageway of the M25 at Junction 13;

"works" means bridge joint replacement work and all associated works;

"a works period" means a period of -

- (i) 7½ hours starting at 2200 hours on Monday 8th September 2014 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2300 hours on Friday 12th September 2014 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 13th September 2014 or on any subsequent Saturday, or
- (iv) 7 hours starting at 2230 hours on Sunday 14th September 2014 or on any subsequent Sunday,

until 8th March 2016.

- **3.** Subject as mentioned in article 4 below, no person shall, during a works period cause or permit any vehicle to enter or proceed in the slip road or the link road.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
 - (a) a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
 - (d) any vehicle being used for winter maintenance purposes.
