# The M1 Motorway (Junction 42 to Junction 44) (Temporary Restriction and Prohibition of Traffic) (No.3) Order 2014 

Made -<br>4th September 2014<br>Coming into force -<br>14th September 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the M1 Motorway, the M62 Motorway, the M621 Motorway and connecting roads, in the District of Leeds, in the County of West Yorkshire, is satisfied that traffic on those motorways and some of those connecting roads should be restricted and prohibited because carriageway resurfacing, road stud replacement, loop cutting, white lining, gully emptying, road sweeping and general maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

1. This Order may be cited as the M1 Motorway (Junction 42 to Junction 44) (Temporary Restriction and Prohibition of Traffic) (No.3) Order 2014 and shall come into force on 14th September 2014.
2. In this Order: -
"the M1" means the M1 Motorway;
"the M62" means the M62 Motorway;
"the M621" means the M621 Motorway;
"the first length of carriageway" means from the nose of the dedicated link road connecting the M62 eastbound carriageway with the M1 northbound carriageway at Lofthouse Interchange to the centre point of Urn Farm overbridge at the M621 Junction 7 (Stourton), a distance of 7339 metres;
"the second length of carriageway" means the M1 northbound carriageway from the nose of the northbound exit slip road at Junction 42 (Lofthouse Interchange) to the nose of the northbound entry slip road at Junction 42, a distance of 1100 metres;
"the third length of carriageway" means the M621 northbound carriageway from the centre point of Clapgate underpass to the centre point of Urn farm overbridge, a distance of 1200 metres;
"the fourth length of carriageway" means the M1 northbound carriageway from the nose of the northbound exit slip road at Junction 43 (Stourton) to the nose of the northbound entry slip road at Junction 44 (Rothwell Haigh), a distance of 3458 metres;
"a slip road" means any of the following slip roads at the, M1:

[^0](i) northbound entry slip road at Junction 42; or
(ii) northbound exit slip road at Junction 44 (Rothwell Haigh);
"the works period" means a period of 10 hours starting at 20:00 hours on Monday 15th September 2014 or any subsequent night thereafter until the said works have been completed;
and a reference to an article followed by a number is a reference to the article in this Order which bears that number.
3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour in the first length of carriageway.
4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the second length of carriageway, the third length of carriageway, the fourth length of carriageway or a slip road.
5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in articles 4 shall apply to:
(a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
(b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
(c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
and nothing in article 3 shall apply to a vehicle being used for the purposes specified in paragraph (a) of this article.
6. No speed limit imposed by this Order applies to vehicles falling within regulations 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
