ROAD TRAFFIC

The A5 Trunk Road (Lutterworth, Leicestershire) (Temporary Prohibition of Traffic) Order 2014

Made - 2nd September 2014 - 9th September 2014 Coming into force -

WHEREAS the Secretary of State for Transport, being the traffic authority for the A5 Trunk Road ("the A5"), is satisfied that traffic on lengths of that road near Lutterworth in the County of Leicestershire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A5 Trunk Road (Lutterworth, Leicestershire) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Tuesday 9th September 2014.

2. In this Order:

"the trunk road" means the northbound carriageway of the A5 from its roundabout junction with the A4303 Coventry Road, B4027 Lutterworth Road and Coal Pit Lane, to a point 500 metres north of its junction with Main Street at Willey;

"the central reservation" means that part of the trunk road which

separates its northbound and southbound carriageways for the safety and guidance of

vehicular traffic using those roads;

"the works period" means the period starting at 20:00 hours on

Tuesday 16th September 2014 and ending when

the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road.

- 4. Subject as mentioned in article 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed through the gap in the central reservation of the trunk road opposite its junction with Main Street.
- 5. Subject as mentioned in article 7, no person shall, during the works period, cause or permit any vehicle to enter or leave the trunk road at its junction with Main Street.
- 6. Subject as mentioned in article 7, no person shall, during the works period, cause or permit any vehicle to turn right onto the northbound carriageway of the A5 at its junction with Ullesthorpe Road.
- 7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle
 - i) being used for police, fire brigade or ambulance purposes;
 - ii) proceeding at the direction of, or with the permission of, a police constable; or
 - iii) being used in connection with the said works.
