## ROAD TRAFFIC

## The A45 Trunk Road (Great Billing, Northampton) (Temporary Restriction and Prohibition of Traffic) Order 2014

Made - - - - 6th October 2014

Coming into force - - 13th October 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A45 Trunk Road ("the A45") and connecting roads, is satisfied that traffic on a length of that road and one of those connecting roads, at Great Billing in the County of Northamptonshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A45 Trunk Road (Great Billing, Northampton) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on Monday 13th October 2014.

2. In this Order –

"the trunk road" means the eastbound carriageway of the A45 from a

point 1500 metres west of the centrepoint of the A5076 Great Billing Way/Crow Lane Interchange roundabout,

to a point 1500 metres east of that centrepoint;

"the slip road" means the slip road leading to the eastbound

carriageway of the A45 from the A5076 Great Billing

Way/Crow Lane Interchange roundabout;

"the works period" means the period starting at 20:00 hours on Monday

20th October 2014 and ending when the said works

have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the trunk road or the slip road.

- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or leave the eastbound carriageway of the A45 at the junctions with Nene Valley Service Area.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- **6.** The provisions of
  - a) article 3 shall not apply to any vehicle being used for special forces purposes;
  - b) articles 3 and 4 shall not apply to any vehicle
    - i. being used for police, fire brigade or ambulance purposes; or
    - ii. proceeding at the direction of, or with the permission of, a police constable; and
  - c) article 4 shall not apply to any vehicle being used in connection with the said works.
