ROAD TRAFFIC

The A50 Trunk Road (Meir, Stoke-On-Trent) (Temporary Prohibition of Traffic) (No.2) Order 2014

Made - - - - 13th October 2014

Coming into force - - 20th October 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50") and connecting roads, is satisfied that traffic on some of those connecting roads, at Meir in the City of Stoke-On-Trent, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A50 Trunk Road (Meir, Stoke-On-Trent) (Temporary Prohibition of Traffic) (No.2) Order 2014 and shall come into force on Monday 20th October 2014.

2. In this Order -

"a slip road" means the slip roads leading to or from the eastbound

or westbound carriageways of the A50 at the roundabout junction with the A520 Sandon

Road/Weston Road, at Meir (Meir Interchange);

"the works period" means the period starting at 20:00 hours on Monday

27th October 2014 and ending when the said works

have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed on a slip road.

- **4.** Subject as mentioned in article 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the dedicated right turn link roads leading
 - a) from the slip road leading to the westbound carriageway of the A50 at Meir Interchange to Broadway; and
 - b) from the exit road from Meir Primary Care Centre to the slip road leading from the westbound carriageway of the A50 at Meir Interchange.
- **5.** Subject as mentioned in article 6, no person shall, during the works period, cause or permit any vehicle to enter or leave a slip road at its junction with
 - a) Broadway; and
 - b) Saracen Lane.
- **6.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle
 - a) being used for police, fire brigade or ambulance purposes;
 - b) proceeding at the direction of, or with the permission of, a police constable;
 - c) being used in connection with the said works; or
 - d) proceeding to or from premises which are accessible from, and only from, a slip road.
