The A43 Trunk Road (Brackley, Northamptonshire) (Temporary Prohibition of Traffic) (No.2) Order 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A43 Trunk Road ("the A43"), is satisfied that traffic on a length of that road, at Brackley the County of Northamptonshire, should be prohibited because of the likelihood of danger to the public.

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(b) of the Road Traffic Regulation Act 1984(**a**), hereby makes the following Order:-

1. This Order may be cited as the A43 Trunk Road (Brackley, Northamptonshire) (Temporary Prohibition of Traffic) (No.2) Order 2014 and shall come into force on Monday 27th October 2014.

2. In this Order –

| "Oxford Road Roundabout" | means the circulatory carriageway of the roundabout junction with the A43, A442 and Oxford Road; |

| "Buckingham Road Roundabout" | means the circulatory carriageway of the roundabout junction with the A43, A442 and Buckingham Road; |
| "Northampton Road Roundabout" | means the circulatory carriageway of the roundabout junction with the A43 and Northampton Road; |
| "central reservation" | means that part of the trunk road which separates its carriageways for the safety and guidance of vehicular traffic using that road; |

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, during the period starting at 20:00 hours on Sunday 2nd November 2014 and ending when the said likelihood of danger has been avoided by means other than this Order, no person shall cause or permit any vehicle to enter or proceed through the gaps in the central reservation of the A43 situated –

- a) 94 metres east of Oxford Road Roundabout;
- b) 94 metres south of Buckingham Road Roundabout;
- c) 100 metres north of Buckingham Road Roundabout; and
- d) 130 metres south of Northampton Road Roundabout.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
