**ROAD TRAFFIC**

**The A590 Trunk Road (Hoad Lane to Arrad Foot) (Temporary Prohibition and Restriction of Traffic) Order 2014**

*Made*        -   -   -   -                      *30th October 2014*

*Coming into force*   -   -                      *16th November 2014*

WHEREAS the Secretary of State for Transport being the traffic authority for the A590 Trunk Road is satisfied that traffic on that trunk road in the District of South Lakeland in the County of Cumbria, should be prohibited and restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1.        This Order may be cited as the A590 Trunk Road (Hoad Lane to Arrad Foot) (Temporary Prohibition and Restriction of Traffic) Order 2014 and shall come into force on 16th November 2014.

2.        In this Order:

          “the trunk road” means the A590 Trunk Road:

          “the length of carriageway” means the eastbound and westbound dual carriageway section, and single carriageway sections, of the trunk road from a point 130 metres east of the centreline of Hoad Lane junction with the trunk road to a point 425 metres east of the centreline of the northern Arrad Foot junction with the trunk road.

          “the works period” means periods overnight between 2000 hours and 0600 hours during a period starting on Monday 17th November 2014 and ending on Sunday 14th December 2014. However, work may start and continue between the same times on subsequent nights or continue until completed, for such period not exceeding 18 months as shall be required to complete the work;

          “works” means drainage and gully cover replacement works on the trunk road.

3.        Subject as mentioned in articles 5 and 6 of this Order no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour in the length of carriageway.

4. Subject as mentioned in article 5 of this Order no person shall, during the works period, cause or permit any vehicle to enter or proceed through the gaps in the central reservation of the trunk road situated 1150 metres west of the centreline of the northern Arrad Foot junction with the trunk road and 898 metres west of the centreline of the northern Arrad Foot junction with the trunk road.
5. The provisions of articles 3 and 4 of this Order shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to any vehicle being used for emergency purposes by the police, fire and rescue authority or ambulance services or anything done at the direction, or with the permission, of a constable, or a traffic officer in uniform.

The provisions of article 4 of this Order shall not apply to any vehicle being used in connection with the said works, to vehicles being used for winter maintenance purposes or by traffic officers.

6. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
