ROAD TRAFFIC

The A12 Trunk Road (Junction 27 Spring Lane Interchange to Junction 29 Crown Interchange) and the A120 Trunk Road (Colchester) Essex (Temporary Restriction and Prohibition of Traffic) Order 2014

Made - - - - 17th November 2014

Coming into force - - 24th November 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A12 Trunk Road ("the A12"), the A120 Trunk Road ("the A120") and connecting roads, is satisfied that traffic on lengths of those roads and on some of those connecting roads in the County of Essex should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A12 Trunk Road (Junction 27 Spring Lane Interchange to Junction 29 Crown Interchange) and the A120 Trunk Road (Colchester) Essex (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on 24th November 2014.

2. In this Order -

"tip of the nosing" means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the trunk road;

"lay-by" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(b); and in this definition "carriageway" means a way of constituting or comprised in a trunk road (other than a cycle track) over which the public have a right of way and which has a surface suitable for the exercise of that right;

"Junction 27", "Junction 28" and "Junction 29" mean, respectively, the A12/A133 Spring Lane Interchange Junction 27, the A12 Severalls Interchange Junction 28 and the A12/A1232 Crown Interchange Junction 29;

- "the first length of trunk road" means the -
- (a) northbound carriageway of the A12 from a point 475 metres south of the centre point of the River Colne over-bridge to a point 220 metres north of the centre point of the A12/A120 eastbound link road over-bridge at Junction 29,
- (b) southbound carriageway of the A12 from a point 165 metres north of the centre point of the Turnpike Close under-bridge to a point 125 metres south of the centre point of B1508 Colchester Road/Braiswick over-bridge, and
- (c) westbound carriageway of the A120 from a point 155 metres east of the centre point of Wyldberry Farm accommodation over-bridge to its merge point with the A12 southbound carriageway at Junction 29;
- "the second length of trunk road" means the -
- (a) northbound carriageway of the A12 between the tips of the nosings of the exit slip road at Junction 27 and the entry slip road at Junction 29,
- (b) southbound carriageway of the A12 between the tips of the nosings of the exit slip road at Junction 29 and the entry slip road at Junction 27, and
- (c) westbound carriageway of the A120 from the tip of the nosing of the exit slip road to the A1232 Ipswich Road to its merge with the entry slip road leading to the southbound carriageway of the A12 at Junction 29;
- "a slip road" means the -
- (a) entry slip roads to the northbound carriageway and the southbound carriageway of the A12 at Junction 28 Severalls Interchange, and
- (b) entry slip road to the westbound carriageway of the A120 from the A1232 Ipswich Road;
- "works" mean slope reconstruction, drainage works, safety fence repairs and carriageway resurfacing;
- "a works period" means a period of 8 hours starting at 22:00 hours on Monday 1st December 2014 or on any subsequent day until the works have been completed;
- "the works period" means the period starting at 00:01 hours on Monday 1st December 2014 and ending when the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour on the first length of trunk road or a slip road.
- **4.** Subject as mentioned in articles 5 and 6 no person shall cause or permit any vehicle to enter or proceed in
 - (a) the second length of trunk road or a slip road, during a works period, or
 - (b) any lay-by adjacent to the first and second lengths of trunk road, during the works period.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.
 - **6.** The provisions of article 4 shall not apply to a vehicle
 - (a) being used in connection with the works or for winter maintenance or traffic officer purposes,
 - (b) being used for police, fire and rescue authority or ambulance purposes, or
 - (c) proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for a purpose specified in paragraph (b) of this article or to a vehicle falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
