The A66 Trunk Road (Lamplugh Roundabout to Westray Farm) (Temporary Prohibition and Restriction of Traffic) (No.3) Order 2014

WHEREAS the Secretary of State for Transport being the traffic authority for the A66 Trunk Road is satisfied that traffic on sections of that trunk road in the District of Allerdale in the County of Cumbria, should be prohibited and restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(**a**), hereby makes the following Order:-

- 1. This Order may be cited as the A66 Trunk Road (Lamplugh Roundabout to Westray Farm) (Temporary Prohibition and Restriction of Traffic) (No. 3) Order 2014 and shall come into force on 26th November 2014.
- **2.** In this Order:

"the trunk road" means the A66 Trunk Road;

"the circulatory carriageway" means the circulatory carriageway of Lamplugh Roundabout;

"the first length of trunk road" means the trunk road from a point 660 metres east of the centreline of the Ellerbeck Brow access road to a point 64 metres east of the centreline of the Simonscales Lane overbridge;

"the second length of trunk road" means the trunk road from a point 798 metres east of the centreline of the Ellerbeck Brow access road to a point 77 metres west of the centreline of the Simonscales Lane overbridge;

"works" means resurfacing and associated works on the trunk road;

"the first works period" means a period starting at 0001 hours on Monday 24th November 2014 and ending at 2359 hours on Sunday 7th December 2014. However, work may start and continue beyond these dates for such period not exceeding 18 months as shall be required to complete the work;

"the second works period" means periods overnight between 2000 hours and 0600 hours starting on Monday 24th November 2014 and ending on Sunday 7th December 2014. However, work may start and continue between the same times on subsequent nights or continue overnight until completed, for such period not exceeding 18 months as shall be required to complete the work.

- **3.** Subject as mentioned in articles 6 and 7 of this Order, during the first works period, no person shall cause or permit any vehicle to be driven in the first length of trunk road or the circulatory carriageway at a speed exceeding 40 miles per hour.
- 4. Subject as mentioned in articles 6 and 7 of this Order, during the second works period, no person shall cause or permit any vehicle to be driven in the second length of trunk road or the circulatory carriageway at a speed exceeding 10 miles per hour whilst traffic signs of a character authorised under Section 64 of the Road Traffic Regulation Act 1984 indicating "convoy working" on that length of road are displayed.
- 5. Subject as mentioned in article 6 of this Order, during the second works period, no person shall cause or permit any vehicle to overtake a moving vehicle in the second length of trunk road.
- 6. The provisions of articles 3, 4 and 5 of this Order shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to a vehicle being used for emergency purposes by the police, fire and rescue authority or ambulance services or anything done at the direction, or with the permission, of a constable, or a traffic officer in uniform.

And nothing in article 5 of this Order shall apply to any vehicle being used in connection with the said works or by traffic officers.

7. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 (a) when used in accordance with regulation 3(5) of those Regulations.
