ROAD TRAFFIC

The M42, M6 and M6 Toll Motorways (M42 Junctions 7 to 9, Coleshill) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 22nd December 2014

Coming into force - - 29th December 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the M42 Motorway ("the M42"), the M6 Motorway ("the M6"), the M6 Toll Motorway ("the M6 Toll") and connecting roads, is satisfied that traffic on a length of the M42 and some of those connecting roads, in the Metropolitan Borough of Solihull and the County of Warwickshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M42, M6 and M6 Toll Motorways (M42 Junctions 7 to 9, Coleshill) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 29th December 2014.

2. In this Order -

"the motorway" means the northbound carriageway of the M42 from

the junction with the link road leading to the northbound carriageway of the M6 (M42 Junction 7), to

the junction with the entry slip road at Junction 9;

"the slip road" means the slip road leading from the northbound

carriageway of the M42 at Junction 9;

"a link road" means the link roads leading –

a) from the northbound carriageway of the M42 to the southbound carriageway of the M6 (M42 Junction 7a):

b) from the southbound carriageway of the M6 to the northbound carriageway of the M42 (M6 Junction 4a);

- c) to the northbound carriageway of the M6 Toll from the junction with the northbound carriageway of the M6 (M6 Junction 3a); and
- d) to the northbound carriageway of the M6 Toll, from the junction with the northbound carriageway of the M42 to the junction with the slip road leading from the A4097 (M42 Junction 9);

"the works period"

means the period starting at 22:00 hours on Monday 5th January 2015 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the motorway, the slip road or a link road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle
 - a) being used for police, fire brigade or ambulance purposes;
 - b) proceeding at the direction of, or with the permission of, a police constable; or
 - c) being used in connection with the said works, or by, or with the permission of, a traffic officer in uniform.
