ROAD TRAFFIC

The A45 Trunk Road (Tollbar End to Thurlaston, Warwickshire) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 22nd December 2014

Coming into force - - 29th December 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A45 Trunk Road ("the A45") and connecting roads, is satisfied that traffic on a length of that road and some of those connecting roads, between Tollbar End and Thurlaston in the City of Coventry and the County of Warwickshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A45 Trunk Road (Tollbar End to Thurlaston, Warwickshire) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 29th December 2014.

2. In this Order –

"Toll Bar End Roundabout" means the circulatory carriageway of the roundabout

junction with the A45 and the A46;

"Ryton Roundabout" means the circulatory carriageway of the roundabout

junction of the A45, A445 Leamington Road and

Wolston Lane:

"Memorial Roundabout" means the circulatory carriageway of the roundabout

junction of the A45 and the B4455 Fosse Way;

"the trunk road" means the westbound carriageway of the A45 from

Ryton Roundabout, to Toll Bar End Roundabout;

"a slip road" means the slip roads leading –

a) from the eastbound carriageway of the A45, to the roundabout junction with the A423 Oxford Road;

- b) to the westbound carriageway of the A45, from the roundabout junction with the A423 Oxford Road;
- c) from and to the westbound carriageway of the A45, at the junction with the A4071; and
- d) from and to the eastbound carriageway of the A45 at the junction with the A4071;

"the works period"

means the period starting at 19:45 hours on Monday 5th January 2015 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.
- **4.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or leave
 - a) the eastbound carriageway of the A45 at the junction with
 - i) Brandon Lane;
 - ii) the access road to 'Whites of Coventry';
 - iii) Stretton Road:
 - iv) the access road to 'Field View'; and
 - v) the access road to Dunchurch Trading Estate;
 - b) the westbound carriageway of the A45 at the junctions with
 - i) Freeboard Lane; and
 - ii) the access and exit roads to and from the 'Lexus' car dealership, south of Tollbar End;
 - c) Ryton Roundabout at the junction with the A445 Leamington Road; and
 - d) Memorial Roundabout at the northern junction with the B4455 Fosse Way.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle
 - a) being used for police, fire brigade or ambulance purposes;
 - b) proceeding at the direction of, or with the permission of, a police constable;
 - c) being used in connection with the said works; or
 - d) proceeding to or from premises which are accessible from, and only from, the A45.
