## ROAD TRAFFIC

## The A52 Trunk Road (Southwest of Nottingham) (Temporary Prohibition of Traffic) Order 2014

Made - - - 29th December 2014

Coming into force - - 5th January 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the A52 Trunk Road ("the A52"), is satisfied that traffic on a length of that road, southwest of the City of Nottingham, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984 (a), hereby makes the following Order: -

1. This Order may be cited as the A52 Trunk Road (Southwest of Nottingham) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 5th January 2015.

## 2. In this Order:

"pedal cycle" has the meaning given in regulation 4 of the Traffic Signs

Regulations and General Directions 2002;

"cycle track" means a way constituting or comprised in a highway,

being a way over which the public have the following, but no other, rights of way, that is to say, a right of way on padal goals with or without a right of way on fact.

pedal cycles with or without a right of way on foot;

"footway" means a way comprised in a highway which also

comprises a carriageway, being a way over which the

public have a right of way on foot only;

"Dunkirk Roundabout" means the circulatory carriageway of the roundabout

junction of the A6005 Beeston Road/Abbey Street and the

slip roads leading to and from the A52;

"the footway/cycle track" means the footway/cycle track adjacent to –

a) the westbound carriageway of the A52 from a point 150 metres southeast of the centreline of the junction with Redfield Road, to a point 150 metres northwest of that

centreline; and

b) Dunkirk Roundabout;

"the works period"

means the period starting at 19:00 hours on Monday 12th January 2015 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or leave the westbound carriageway of the A52 at the junction with Redfield Road, southeast of Dunkirk Roundabout.
- **4.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any person using a pedal cycle to enter or proceed in the footway/cycle track.
- **5**. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any pedestrian to enter or proceed in the footway/cycle track.
- **6.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - 7. The provisions of
    - a) article 3 shall not apply to any vehicle
      - i. being used for police, fire brigade or ambulance purposes;
      - ii. proceeding at the direction of, or with the permission of, a police constable; or
      - iii. being used in connection with the said works; and
    - b) articles 4 and 5 shall not apply to any person
      - i. engaged in police, fire brigade or ambulance activity; or
      - ii. engaged in activity connected with the works.
