ROAD TRAFFIC

The A2 Trunk Road (Cobham Interchange - Cycle Track) (Temporary Prohibition of Traffic) Order 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A2 Trunk Road ("the A2"), is satisfied that traffic on a length of that road in the County of Kent should be restricted and prohibited because works are proposed to be executed thereon:

NOW THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:

1. This Order may be cited as the A2 Trunk Road (Cobham Interchange - Cycle Track) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 17th January 2015.

2. In this Order -

"cycle track" has the meaning given in the Highways Act 1980(b)

"the cycle track" means the cycle track adjacent to the eastbound carriageway of the A2 trunk road between a point 398 metres west of the Cobham Flyover (Brewers Road) and a point 54 metres north of the A2 trunk road.;

"the works" mean partial reconstruction of the cycle track and associated works;

"the works period" means the period starting at 06.00 hours on Monday 19th January 2015 until 16th July 2015;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall during a works period cause or permit any pedestrian, or person using a pedal cycle with four wheels or fewer and not being a mechanically propelled vehicle, to enter or proceed in the cycle track.

4. The provisions of articles 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

5. Nothing in article 3 shall apply to -

- (a) any constable or pedestrian
 - (i) engaged in the said works,

- (ii) engaged in the ambulance or fire brigade service,
- (iii) leaving a vehicle that is prevented from proceeding by circumstances beyond his or her control, or
- (b) anything done at the direction, or with the permission, of a constable, or a traffic officer in uniform;

and nothing in article 4 shall apply to a vehicle being used for the purpose specified in paragraph (b) of this article.
