ROAD TRAFFIC

The A3 Trunk Road (Painshill Interchange, Slip Roads) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 13th January 2014

Coming into force - - 1st February 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A3 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A3 Trunk Road (Painshill Interchange, Slip Roads) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 1st February 2014.

2. In this Order:

"the trunk road" means the A3 Trunk Road in the County of Surrey;

"a slip road" means -

- (i) the road leading from the southbound carriageway of the trunk road to the roundabout at Painshill Interchange (A245), or
- (ii) the road leading to the northbound carriageway of the trunk road from the roundabout at Painshill Interchange (A245), or
- (iii) the road leading from the northbound carriageway of the trunk road to the roundabout at Painshill Interchange (A245), or
- (iv) the road leading to the southbound carriageway of the trunk road form the roundabout at Painshill Interchange (A245);

"works" mean carriageway resurfacing, expansion joint repair, white lining work and all associated carriageway work; and

"a works period" means a period of -

- (i) 7 hours starting at 2200 hours on Monday 3rd February 2014 any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 6 hours starting at 2300 hours on Friday 7th February 2014 or on any subsequent Friday, until 31st July 2015.
- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a slip road.

- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to
 - (a) a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, fire and rescue authority, ambulance or traffic officer purposes;
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
 - (d) any vehicle being used for winter maintenance purposes.
