ROAD TRAFFIC

The A50 Trunk Road (Thulston, Derbyshire) (Temporary Restriction and Prohibition of Traffic) Order 2014

Made - - - - 21st February 2014

Coming into force - - 28th February 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50"), is satisfied that traffic on lengths of that road in the County of Derbyshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A50 Trunk Road (Thulston, Derbyshire) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on Friday 28th February 2014.

2. In this Order:

"the first length of trunk road" means the eastbound carriageway of the A50 from a

point 3200 metres south of its junction with the slip road leading to the northbound carriageway of the A6 (A50 Junction 2), to its junction with the slip road leading to the northbound carriageway of the A6 (A50

Junction 2);

"the second length of trunk road" means the eastbound carriageway of the A50 from its

junction with the slip road leading to the northbound carriageway of the A6,to its junction with the slip road leading from the southbound carriageway of the A6

(A50 Junction 2);

"the works period" means the period starting at 20:00 hours on Friday 7th

March 2014 and ending when the said works have been

completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the first length of trunk road.

- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the second length of trunk road.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - **6.** The provisions of
 - (a) articles 3 and 4 shall not apply to any vehicle -
 - (i) being used for police, fire brigade or ambulance purposes; or
 - (ii) proceeding at the direction of, or with the permission of, a police constable;
 - (b) article 3 shall not apply to any vehicle being used for special forces purposes; and
 - (c) article 4 shall not apply to any vehicle being used in connection with the said works.
