ROAD TRAFFIC

The A1 Trunk Road (Warreners House Junction to Seaton Burn Interchange) (Temporary Restriction and Prohibition of Traffic) Order 2014

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1 Trunk Road and connecting roads, in the County of Northumberland, is satisfied that traffic on that trunk road and one of those connecting roads should be restricted and prohibited because layby enhancement, road marking, sign renewal, footpath construction and routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(**a**), makes the following Order:

1. This Order may be cited as the A1 Trunk Road (Warreners House Junction to Seaton Burn Interchange) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on 2nd March 2014.

2. In this Order:-

"the A1" means the A1 Trunk Road;

"the first length of carriageway" means the A1 southbound carriageway from a point 800 metres south of the centreline of Warreners House Junction overbridge southwards for a distance of approximately 1800 metres;

"the second length of carriageway" means the A1 southbound carriageway from a point 3450 metres north of the centreline of Clifton Junction overbridge southwards for a distance of approximately 3250 metres;

"the third length of carriageway" means the A1 southbound carriageway from a point 400 metres south of the centreline of Clifton Junction overbridge southwards for a distance of approximately 1800 metres;

"the fourth length of carriageway" means the A1 southbound carriageway from a point 1800 metres north of the centreline of Stannington North Junction southwards for a distance of approximately 4000 metres;

"the slip road" means the A1 southbound exit slip road at Shotton Junction;

"a layby" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means any way (other than a cycle track) comprised in the A1 over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"the first works period" means a period of 10 hours starting at 20:00 hours on Monday 3rd March 2014 and ending when the said works have been completed;

"the second works period" means the period starting at 00:01 hours on Monday 3rd March 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 6 no person shall, during the first works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour in the first length of carriageway, the second length of carriageway, the third length of carriageway or the fourth length of carriageway.

4. Subject as mentioned in article 6 no person shall, during the first works period, cause of permit any vehicle to enter or proceed in the slip road.

5. Subject as mentioned in article 6 no person shall, during the second works period, cause or permit any vehicle to enter or wait in a layby situated adjacent to the A1:

- (i) southbound carriageway approximately 2100 metres south of Warreners House Junction overbridge;
- (ii) southbound carriageway approximately 500 metres north of Clifton Junction overbridge;
- (iii) southbound carriageway approximately 1000 metres north of Stannington North Junction; or
- (iv) southbound carriageway approximately 550 metres north of Shotton Junction overbridge;

6.The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs. Nothing in article 4 and 5 shall apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for the purpose specified in paragraph (a) of this article;

and nothing in article 4 and 5 shall apply to any vehicle proceeding in the A1 to or from premises and property which is accessible for that vehicle, from, and only from, that road.

7. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations $2011(\mathbf{a})$ when used in accordance with regulation 3(5) of those Regulations.
