**ROAD TRAFFIC**

**The A1(M) Motorway (Junction 36, Warmsworth) (Temporary Prohibition of Traffic) Order 2014**

*Made* - - - - *9th January 2014*

*Coming into force* - *12th January 2014*

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway and connecting roads, in the District of Doncaster, in the County of South Yorkshire, is satisfied that traffic on those connecting roads should be prohibited because traffic signals, resurfacing, traffic signs, lighting and barrier works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

**1.** This Order may be cited as the A1(M) Motorway (Junction 36, Warmsworth) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 12th January 2014.

**2.** In this Order:-

“the first slip road” means the A1(M) Motorway southbound exit slip road at Junction 36;

“the second slip roads” means the A1(M) Motorway northbound exit and entry slip roads and southbound entry slip road at Junction 36;

“the first works period” means a period starting at 20:00 hours on Monday 13th January 2014 and ending when the said works have been completed;

“the second works period” means a period of:

- (i) 10 hours starting at 20:00 hours on Monday 13th January 2014 or any subsequent Monday, Tuesday, Wednesday, Thursday or Sunday night thereafter until the said works have been completed;
- (ii) 13 hours starting at 21:00 hours on Friday 17th January 2014 or any subsequent Friday night thereafter until the said works have been completed; or
- (iii) 14 hours starting at 20:00 hours on Saturday 18th January 2014 or any subsequent Saturday night thereafter until the said works have been completed.

**3.** Subject as mentioned in article 4 of this Order, no person shall cause or permit any vehicle to enter or proceed in the first slip road during the first works period or the second slip roads during the second works period.

4. The provisions of article 3 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
