ROAD TRAFFIC

The A50 Trunk Road (Blythe Bridge, Staffordshire) (Slip Roads) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 28th February 2014

Coming into force - - 7th March 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50") and connecting roads, is satisfied that traffic on some of those connecting roads, at Blythe Bridge, in the County of Staffordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1) (a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A50 Trunk Road (Blythe Bridge, Staffordshire) (Slip Roads) (Temporary Prohibition of Traffic) Order 2014 and shall come into force Friday 7th March 2014.

2. In this Order:

"Meir Roundabout" means the circulatory carriageway of the A50 at its

junction with the A521 Uttoxeter Road and Lysander

Road;

"Grindley Roundabout" means the circulatory carriageway of the A50 at its

junction with the B5029 Grindley Lane;

"a slip road" means the slip roads leading –

a) to the eastbound carriageway of the A50 from its

junction with Meir Roundabout;

b) from the westbound carriageway of the A50 to its

junction with Meir Roundabout;

c) from the eastbound carriageway of the A50 to its

junction with Grindley Roundabout;

d) to the eastbound carriageway of the A50 from its

junction with Grindley Roundabout;

e) from the westbound carriageway of the A50 to its

junction with Grindley Roundabout;

f) to the westbound carriageway of the A50 from its junction with Grindley Roundabout;

"the works period"

means the period starting at 00:01 hours on Saturday 8th March 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in a slip road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle
 - (i) being used for police, fire brigade or ambulance purposes;
 - (ii) proceeding at the direction of, or with the permission of, a police constable; or
 - (iii) being used in connection with the said works.
