## **ROAD TRAFFIC**

## The A63 Trunk Road (Garrison Roundabout to Southcoates Roundabout) (Temporary Prohibition of Traffic) Order 2014

Made - - - 6th March 2014

Coming into force - 16th March 2014

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A63 Trunk Road and connecting roads, in the District of Kingston upon Hull, is satisfied that traffic on that trunk road and some of those connecting roads should be prohibited because carriageway resurfacing, traffic loop reinstallation and lining renewal works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

**1.** This Order may be cited as the A63 Trunk Road (Garrison Roundabout to Southcoates Roundabout) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 16th March 2014.

## 2. In this Order:-

"the A63" means the A63 Trunk Road;

"the eastbound and westbound carriageways" means respectively the A63 eastbound and westbound carriageways between their junctions with Garrison Roundabout and Southcoates Roundabout, a distance of 1630 metres;

"a slip road" means any of the following A63 slip roads:

- (i) westbound entry slip road at Mount Pleasant South Roundabout;
- (ii) westbound exit slip road at Alexandra Docks Roundabout; or
- (iii) eastbound exit slip road at Mount Pleasant North Roundabout;

"bus stop area" means any area of carriageway on a side of the A63, intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagrams 1025.1, 1025.3 or 1025.4 in schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**);

"the works period" means a period of 12 hours starting at 19:00 hours on Monday 17th March 2014 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the eastbound and westbound carriageways or a slip road.

- **4.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or wait in a bus stop area situated adjacent to the A63:
  - (i) westbound carriageway approximately 125 metres east of Garrison Roundabout: or
  - (ii) eastbound carriageway approximately 125 metres east of Garrison Roundabout.
  - **5.** The provisions of articles 3 and 4 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
    - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
    - (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
    - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
