## ROAD TRAFFIC

# The M4 Motorway (Junctions 15-18) (Temporary Restriction and Prohibition of Traffic) Order 2014

Made - - - - 30th December 2014

Coming into force - - 3rd January 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the M4 Motorway ("the M4") and connecting roads, is satisfied that traffic on lengths of that road and some of those connecting roads between Junctions 15 and 18 in Wiltshire and in South Gloucestershire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) and regulation 16(2) of the Motorways Traffic (England and Wales) Regulations 1982(b), hereby makes the following Order:

**1.** This Order may be cited as the M4 Motorway (Junctions 15-18) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force on 3rd January 2015.

### 2. In this Order -

"the first length of the M4" means (i) the westbound carriageway of the M4 from the tip of the nosing of the westbound entry slip road at Junction 15 to the tip of the nosing of the westbound exit slip road at Junction 18; and (ii) the eastbound carriageway of the M4 from the tip of the nosing of the eastbound entry slip road at Junction 18 to the tip of the nosing of the eastbound exit slip road at Junction 15;

"the second length of the M4" means (i) the westbound carriageway of the M4 at Junction 16 between the tip of the nosing of the westbound exit slip road and the tip of the nosing of the westbound entry slip road; (ii) the eastbound exit slip road and the tip of the nosing of the eastbound entry slip road; (iii) the westbound carriageway of the M4 at Junction 17 between the tip of the nosing of the westbound exit slip road and the tip of the nosing of the westbound entry slip road; and (iv) the eastbound carriageway of the M4 at Junction 17 between the tip of the nosing of the eastbound exit slip road and the tip of the nosing of the eastbound exit slip road and the tip of the nosing of the eastbound exit slip road and the tip of the nosing of the eastbound entry slip road:

"the slip roads" mean (i) the eastbound and westbound exit and entry slip roads at M4 Junction 16; and (ii) the eastbound and westbound exit and entry slip roads at M4 Junction 17; "the Regulations" means the Motorways Traffic (England and Wales) Regulations 1982;

"tip of the nosing" means the first point where an entry slip road joins the carriageway of a motorway or the last point where an exit slip road leaves the carriageway of a motorway;

"the hard shoulder" means the hard shoulder within the meaning of regulation 3(1)(e) of the Regulations which is adjacent to the first length of the M4 and the slip roads;

"the works" mean resurfacing, white lining, loop cutting, stud replacement, bridge joint replacement and surveying works;

"a works period" means a period of 10 hours starting at 20.00 hours on Tuesday 6th January 2015 or on any subsequent day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to an article in this Order which bears that number.

- 3. Subject as mentioned in articles 4, 5 and 7, no person shall, during a works period:
  - (a) drive any motor vehicle at a speed exceeding 50 miles per hour on the first length of the M4 and the slip roads;
  - (b) cause or permit any vehicle to enter or proceed on the second length of the M4 and the slip roads.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:
  - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes; or
  - (b) anything done at the direction of, or with the permission of, a constable.
- **5.** The provisions of article 3(b) shall not apply to a vehicle being used in connection with the said works, for traffic officer purposes or for winter maintenance purposes.
- **6.** During a works period, regulation 5 and (insofar as it relates to a vehicle being driven) regulation 9 of the Regulations are hereby suspended, in respect of the hard shoulder, at such times and to such extent as shall from time to time be indicated by traffic signs.
- 7. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
