ROAD TRAFFIC

The A1(M) Motorway (Junction 35 to Junction 37) (Temporary Prohibition of Traffic) Order 2015

Made - - - - 29th January 2015

Coming into force - - 8th February 2015

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway and connecting roads, in the District of Doncaster, in the County of South Yorkshire, is satisfied that traffic on that motorway and some of those connecting roads should be prohibited because carriageway resurfacing, renewal of road studs and markings and routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

- **1.** This Order may be cited as the A1(M) Motorway (Junction 35 to Junction 37) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on 8th February 2015.
- **2.** Subject as mentioned in article 3 of this Order, no person shall, during a period of 10 hours starting at 20:00 hours on Monday 9th February 2015 or any subsequent night thereafter until the said works have been completed, cause or permit any vehicle to enter or proceed in the A1(M) Motorway:
 - (i) southbound carriageway from the nose of the southbound exit slip road at Junction 37 (Marr) to the nose of the southbound entry slip road at Junction 36 (Warmsworth), a distance of 6410 metres;
 - (ii) southbound carriageway from the nose of the southbound exit slip road at Junction 36 to the nose of the southbound entry slip road at Junction 35 (Wadworth), a distance of 4150 metres;
 - (iii) northbound carriageway from the nose of the northbound exit slip road at Junction 35 to the nose of the northbound entry slip road at Junction 36, a distance of 4000 metres;
 - (iv) northbound carriageway from the nose of the northbound exit slip road at Junction 36 to the nose of the northbound entry slip road at Junction 37, a distance of 6410 metres;
 - (v) northbound and southbound entry and exit slip roads at Junction 35;
 - (vi) northbound and southbound entry and exit slip roads at Junction 36; or
 - (vii) northbound and southbound entry and exit slip roads at Junction 37.
- **3.** The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
