The Air Navigation (Restriction of Flying) (Stokes Bay) Regulations 2015

Made - - - - 19th March 2015

Coming into force - - 22nd March 2015

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of Stokes Bay, Hampshire, by reason of the visit to the United Kingdom of the USS Theodore Roosevelt (CVN-71) during the period from 22nd to 27th March 2015.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Stokes Bay) Regulations 2015 and come into force on 22nd March 2015.

Interpretation

2. In regulation 3(1) all times referred to are Co-ordinated Universal Time(**b**).

Restricted airspace

- **3.**—(1) Subject to paragraph (2), between 0700 hours on 22nd March 2015 and 2300 hours on 27th March 2015, no aircraft is to fly below 1,500 feet above mean sea level within the area bounded by a circle having a radius of 1 nautical mile whose centre is at 514606N 0011042W.
 - (2) Paragraph (1) does not apply to any aircraft flying—
 - (a) in the service of the National Police Air Service,
 - (b) in the service of the Helicopter Emergency Medical Services,
 - (c) in the service of the Maritime & Coastguard Agency,
 - (d) with the permission of the Chief Officer of Police for Hampshire, or
 - (e) with a clearance issued by Plymouth Military Radar.

⁽b) In these Regulations Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

EXPLANATORY NOTE

(This note is not part of the Regulations)

The USS Theodore Roosevelt is scheduled to visit the United Kingdom during the period from 22nd March to 27th March 2015. The ship has a complement in excess of 5,000 personnel and is fitted with a nuclear-powered propulsion system. For security and public safety reasons, Hampshire Constabulary has requested the Secretary of State to make restriction of flying regulations for the area in the vicinity of Stokes Bay during the period of the visit. This request has been agreed with the Civil Aviation Authority's Safety and Airspace Regulation Group and the Department for Transport.

The times mentioned in regulation 3(1) are Universal Co-ordinated Time (UTC), which for the purpose of these Regulations is one hour behind British Summer Time.
