ROAD TRAFFIC

The A50 Trunk Road (Sudbury - Foston, Derbyshire) (Temporary Restriction and Prohibition of Traffic) Order 2015

> Made - 17th February 2015 Coming into force -- 24th February 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50") and connecting roads, is satisfied that traffic on lengths of that road and one of those connecting roads, in the County of Derbyshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order:-

1. This Order may be cited as the A50 Trunk Road (Sudbury - Foston, Derbyshire) (Temporary Restriction and Prohibition of Traffic) Order 2015 and shall come into force on Tuesday 24th February 2015.

2. In this Order -

"A511 Interchange" means the dumbbell roundabout junction of the A511 and

the slip roads leading to and from the A50, east of Foston;

"A515 Interchange" means the circulatory carriageway of the roundabout

junction of the A50 and the A515, east of Sudbury;

means the westbound carriageway of the A50 from a "the first length of trunk road"

point 1 kilometre east of the centre point of the junction with the slip road leading from the A511 Interchange, to

that centre point;

"the second length of trunk road"

means -

- a) the eastbound carriageway of the A50 from the A515 Interchange, to the junction with the slip road leading from the A511 Interchange; and
- b) the westbound carriageway of the A50 from the junction with the slip road leading to the A511 Interchange, to the A515 Interchange;

"the slip road" means the slip road leading to the westbound carriageway

of the A50 from the A511 Interchange;

"the works period" means the period starting at 20:00 hours on Tuesday 3rd

March 2015 and ending when the said works have been

completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour in the first length of trunk road.

- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the second length of trunk road or the slip road.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - **6.** The provisions of:
 - (a) articles 3 and 4 shall not apply to any vehicle -
 - (i) being used for police, fire brigade or ambulance purposes, or
 - (ii) proceeding at the direction of, or with the permission of, a police constable;
 - (b) article 3 shall not apply to any vehicle being used for special forces purposes; and
 - (c) article 4 shall not apply to any vehicle being used in connection with the said works.
