### ROAD TRAFFIC

# The A38 Trunk Road (Largin Wood, Near Dobwalls) (Temporary Prohibition of Traffic) Order 2015

*Made - - - - 24th February 2015* 

Coming into force - - 27th February 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the A38 Trunk Road ("the A38"), is satisfied that traffic on lengths of that road near Dobwalls in Cornwall should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A38 Trunk Road (Largin Wood, Near Dobwalls) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on 27th February 2015.

#### 2. In this Order –

"the A38" means the A38 near Dobwalls from its junction with North Lane to the western edge of Twelvewoods Roundabout (the junction with the A390);

"bicycle" means a pedal cycle with fewer than four wheels and not being a mechanically propelled vehicle;

"layby" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means any way (other than a cycle track) comprised in the trunk road over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"the works" mean drainage improvements and maintenance operations;

"a works period" means a period of 10 hours starting at 20.00 hours on Sunday 1st March 2015 or on any subsequent day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in articles 6 and 7, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the A38.

- **4.** Subject as mentioned in article 6, no person shall, during a works period, cause or permit any vehicle to enter, proceed or remain in the laybys adjacent to:
  - (a) the A38 eastbound between its junction with North Lane and Twelvewoods Roundabout; and
  - (b) the A38 westbound between Twelvewoods Roundabout and its junction with Drift Lane.
- **5.** Subject as mentioned in article 6, no person using a bicycle shall enter or proceed in the A38 during a works period.
- **6.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:
  - (a) a vehicle being used for police, traffic officer, fire and rescue authority or ambulance purposes;
  - (b) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
  - (c) a vehicle being used in connection with the said works or for winter maintenance purposes.
- 7. The provisions of article 3 shall not apply to a vehicle proceeding to or from premises that are accessible from and only from the A38.
