ROAD TRAFFIC

The M180 Motorway (Junction 2 to Junction 5) (Temporary Prohibition of Traffic) Order 2015

Made - - - 19th February 2015

Coming into force - 1st March 2015

WHEREAS, the Secretary of State for Transport, being the traffic authority for the M180 Motorway, the M181 Motorway and connecting roads, in the District of North Lincolnshire, in the County of Lincolnshire, is satisfied that traffic on those motorways and some of those connecting roads should be prohibited because road resurfacing, road markings, road stud renewal, sign renewal and verge maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the M180 Motorway (Junction 2 to Junction 5) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on 1st March 2015.
- **2.** Subject as mentioned in article 3 of this Order, no person shall, during a period of 10 hours starting at 20:00 hours on Monday 2nd March 2015 or any subsequent night thereafter until the said works have been completed, cause or permit any vehicle to enter or proceed in the:
 - (i) M180 Motorway eastbound carriageway from the nose of the exit slip road at Junction 2 (Woodhouse) to the nose of the entry slip road at Junction 5 (Barnetby), a distance of 29800 metres;
 - (ii) M180 Motorway westbound carriageway from the nose of the exit slip road at Junction 5 to the nose of the entry slip road at Junction 2, a distance of 29800 metres;
 - (iii) M180 Motorway eastbound entry and westbound exit slip roads at Junction 2;
 - (iv) link roads connecting the M180 Motorway eastbound or westbound carriageways with the M181 Motorway northbound or southbound carriageways at Midmoor Interchange (M180 Motorway Junction 3);
 - (v) M180 Motorway eastbound and westbound entry and exit slip roads at Junction 4 (Broughton); or
 - (vi) M180 Motorway eastbound exit and westbound entry slip roads at Junction 5.
- **3.** The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
