ROAD TRAFFIC

**The A5148 and A38 Trunk Roads (Lichfield, Staffordshire)
(Temporary Prohibition of Traffic) Order 2015**

Made - - - - *2nd March 2015*
Coming into force - - *9th March 2015*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A5148 Trunk Road (“the A5148”), the A38 Trunk Road (the A38) and connecting roads, is satisfied that traffic on a length of that road and some of those connecting roads, near Lichfield in the County of Staffordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A5148 and A38 Trunk Roads (Lichfield, Staffordshire) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on Monday 9th March 2015.

2. In this Order –

“the trunk road”

means –

- a) the northbound carriageway of the A5148 from the junction with the dumbbell roundabout at the junction with the A5 and A5127 Birmingham Road, to the junction with the slip road leading from the roundabout junction with the A38 London Road; and
- b) the southbound carriageway of the A5148 from the junction with the slip road leading to the roundabout junction with the A38 London Road, to the dumbbell roundabout at the junction with the A5 and A5127 Birmingham Road;
- c) the northbound carriageway of the A38 from the junction with the slip road leading from the A38/A51/A5148 roundabout junction to its junction with the link road leading from the A5127; and

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1

- d) the southbound carriageway of the A38 from its junction with the link road leading to the A5127 to its junction with the slip road leading to the A38/A51/A5148 roundabout junction;

“the link road” means the link road leading from the southbound carriageway of the M6 Toll at Junction T5, to the northbound carriageway of the A5148;

“a slip road” means the slip roads leading –
a) to and from the northbound and southbound carriageways of the A5148 at the roundabout junction with the A38 London Road;
b) to and from the northbound and southbound carriageways of the A38 at the roundabout junction with the A38 London Road.

"the works period" means the period starting at 20:00 hours on Monday 16th March 2015 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the trunk road, the link road or a slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- a) being used for police, fire brigade or ambulance purposes;
- b) proceeding at the direction of, or with the permission of, a police constable; or
- c) being used in connection with the said works.
