ROAD TRAFFIC

The M25 Motorway (Junctions 19 – 21A) (Temporary Restriction and Prohibition of Traffic) (No. 2) Order 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the M25 Motorway and connecting roads, is satisfied that traffic should be restricted and prohibited on lengths of that road and prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M25 Motorway (Junction 19 - 21A) (Temporary Restriction and Prohibition of Traffic) (No. 2) Order 2015 and shall come into force on 11th April 2015.

2. In this Order:

"the motorway" means the M25 motorway in the County of Hertfordshire;

"the tip of the nosing" means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the motorway;

"the first length of carriageway" means the clockwise carriageway of the motorway between the tip of the nosing of the "off" link road at Junction 19 (A41) and Bedmond Road overbridge;

"the second length of carriageway" means the anti-clockwise carriageway of the motorway between the tip of the nosing of the "off" slip road at Junction 21A (A405) and Old House Lane overbridge;

"the third length of carriageway" means the clockwise carriageway of the motorway between the tip of the nosing of the 'off' link road at Junction 19 (A41) and the tip of the nosing of the 'on' slip road at Junction 21A (A405);

"the fourth length of carriageway" means the anti-clockwise carriageway of the motorway between the tip of the nosing of the 'off' slip road at Junction 21A (A405) and the tip of the nosing of the 'on' slip road at Junction 20 (A41);

"the fifth length of carriageway" means the clockwise carriageway of the motorway between the tip of the nosing of the "off" slip road at Junction 20 (A41) to the tip of the nosing of the "on" link road from the southbound carriageway of the M1 motorway at Junction 21;

"a first slip road" means -

- (i) the roads leading to and from the clockwise carriageway of the motorway from A41 at Junction 20,
- (ii) the road leading from the anti-clockwise carriageway of the motorway to the A41 at Junction 20,
- (iii) the road leading from the clockwise carriageway of the motorway to the A405 at Junction 21A, or

"the second slip road" means the road leading to the anti-clockwise carriageway of the motorway from the A405 at Junction 21A;

"a first link road" means -

- (i) the road leading from the clockwise carriageway of the motorway to the northbound carriageway of the M1 at Junction 21,
- (ii) the road leading to the clockwise carriageway of the motorway from the southbound carriageway of the M1 at Junction 21,
- (iii) the road leading from the anti-clockwise carriageway of the motorway to the northbound carriageway of the M1 at Junction 21, or

"the second link road" means the road leading to the anti-clockwise carriageway of the motorway from the southbound carriageway of the M1 at Junction 21;

"works" mean replacement of joints at Gade Valley Viaduct and all associated work;

"a first works period" means a period of -

- (i) 8 hours starting at 2130 hours on Monday 13th April 2015 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 8 hours starting at 2200 hours on Friday 17th April 2015 or on any subsequent Friday,
- (iii) 13 hours starting at 2100 hours on Saturday 18th April 2015 or on any subsequent Saturday,
- (iv) 7¹/₂ hours starting at 2200 hours on Sunday 19th April 2015 or on any subsequent Sunday,

until 22nd September 2016; and

"a second works period" means a period of 24 hours starting at 0001 hours on Monday 13th April 2015 or on any subsequent day until 22nd September 2016.

3. Subject as mentioned in articles 7 and 8 below, no person shall, during a first works period cause or permit any vehicle to enter or proceed in a first slip road, the second slip road, a first link road, the second link road, the third length of carriageway or the fourth length of carriageway.

4. Subject as mentioned in articles 7 and 8 below, no person shall, during a first works period drive any motor vehicle at a speed exceeding 40 miles per hour on the first length of carriageway or the second length of carriageway.

5. Subject as mentioned in articles 7 and 8 below, no person shall, during a second works period cause or permit any vehicle exceeding the weight of 80 tonnes to enter or proceed in the second slip road, the second length of carriageway or the fifth length of carriageway.

6. The provisions of articles 3, 4, 5 and 6 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs.

- 7. (1) Nothing in article 3 shall apply to -
 - (a) a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
 - (d) any vehicle being used for winter maintenance purposes.

(2) Nothing in article 4 above shall apply to a vehicle being used for police, ambulance or fire and rescue authority purposes and to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

8. The M25 Motorway (Junctions 19 - 21A) (Temporary Restriction and Prohibition of Traffic) Order $2015(\mathbf{b})$ is hereby revoked.
