**The A11 Trunk Road (Fiveways to Thetford Improvement)  
(Detrunking) 2011 (Amendment) Order 2015**

*Made* - - - - - *18th March 2015*

*Coming into force* - - - - - *25th March 2015*

The Secretary of State for Transport makes this Order in exercise of powers conferred by sections 10 and 12 of the Highways Act 1980 **(a)** and now vested in him **(b)** and **(c)**:

**1.** This Order may be cited as the A11 Trunk Road (Fiveways to Thetford Improvement) (Detrunking) Order 2011 (Amendment) Order 2015 and shall come into force on 25th March 2015.

**2.** The A11 Trunk Road (Fiveways to Thetford Improvement) (Detrunking) 2011 Order is hereby amended as follows:

- (a) For the schedule to that Order substitute the schedule to this Order.
- (b) For the plan numbered HA 10/MP/072, referred to in the A11 Trunk Road (Fiveways to Thetford Improvement) (Detrunking) 2011 Order substitute the plan to The A11 Trunk Road (Fiveways to Thetford Improvement) (Detrunking) 2011 (Amendment) Order 2015.

**SCHEDULE**  
**LENGTH OF THE TRUNK ROAD CEASING TO BE A TRUNK**  
**ROAD**

The length of the trunk road ceasing to be a trunk road is situated between a point 1085 metres west along the trunk road from the centreline of the B1106 junction from Bury St Edmunds at Elveden in the County of Suffolk and a point 2845 metres east of the B1106 junction to the Banjo Turn where the slip road begins at Elveden Gap in the County of Norfolk and is shown by broad black dashes on the plan marked “The A11 Trunk Road (Fiveways to Thetford Improvement) (Detrunking) 2011 (Amendment) Order 2015” signed by authority of the Secretary of State for Transport and deposited at Document Deposit Service, Communities and Local Government, Floor 13 (IMD), Ashdown House, St Leonards on Sea, Hastings, East Sussex TN37 7GA.

## **EXPLANATORY NOTE**

This Order re-classifies the section of existing A11 Trunk Road which passes through Elveden village. The relevant section will become a County 'C' road and the new A11 Trunk Road will bypass the village.
