ROAD TRAFFIC

The A50 Trunk Road (Hilton to Findern, Derbyshire) (Temporary Prohibition of Traffic) Order 2015

Made - - - - 23rd February 2015

Coming into force - - 2nd March 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50") and connecting roads, is satisfied that traffic on a length of that road and two of those connecting roads, between Hilton and Findern in the County of Derbyshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A50 Trunk Road (Hilton to Findern, Derbyshire) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on Monday 2nd March 2015.

2. In this Order:

"the A516 Interchange" means the dumbbell roundal

means the dumbbell roundabout junction of the A50, the

A516 Derby Road and the A5132 Derby Road;

"the A38 Interchange" means the circulatory carriageway of the roundabout

junction of the A50 and the A38 Burton Road, known as

Toyota Roundabout;

"the trunk road" means –

 a) the eastbound carriageway of the A50 from the junction with the slip road leading to the A516 Interchange, to the junction with the slip road leading from the A38 Interchange; and

b) the westbound carriageway of the A50 from the junction with the slip road leading to the A38 Interchange, to the junction with the slip road leading from the A516 Interchange;

"a slip road"

means the slip roads leading -

- a) to the eastbound carriageway of the A50 from the A516 Interchange; and
- b) to the westbound carriageway of the A50 from the A38 Interchange;

"the works period"

means the period starting at 20:00 hours on Monday 9th March 2015 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle-
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable; or
 - (c) being used in connection with the said works.
