ROAD TRAFFIC

The A50 Trunk Road (Foston to Etwall, Derbyshire) (Temporary Prohibition of Traffic) Order 2015

Made - - - - 19th January 2015

Coming into force - - 26th January 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50") and connecting roads, is satisfied that traffic on a length of that road and two of those connecting roads, between Foston and Etwall in the County of Derbyshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A50 Trunk Road (Foston to Etwall, Derbyshire) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on Monday 26th January 2015.

2. In this Order:

"the A511 Interchange" means the dumbbell roundabout junction of the A50 and

the A511 Uttoxeter Road;

"the A516 Interchange" means the circulatory carriageway of the dumbbell

roundabout junction of the A50 and the A516 Derby Road;

"the trunk road" means –

 a) the eastbound carriageway of the A50 from the junction with the slip road leading to the A511 Interchange, to the junction with the slip road leading from the A516 Interchange; and

b) the westbound carriageway of the A50 from the junction with the slip road leading to the A516 Interchange, to the junction with the slip road leading from the A511 Interchange;

"a slip road" means the slip roads leading –

 a) to the eastbound carriageway of the A50 from the A511 Interchange; and

b) to the westbound carriageway of the A50 from the A516 Interchange;

"the works period"

means the period starting at 20:00 hours on Monday 2nd February 2015 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle-
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable; or
 - (c) being used in connection with the said works.
