# The Air Navigation (Restriction of Flying) (Clacton-on-Sea) Regulations 2016

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of Clacton-on-Sea, Essex by reason of the holding of an air show that is scheduled to take place there.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order  $2009(\mathbf{a})$ .

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Clacton-on-Sea) Regulations 2016 and come into force on 25th August 2016.

#### Interpretation

**2.** In regulation 3(1) the times referred to are Co-ordinated Universal Time(**b**).

### **Restricted airspace**

**3.**—(1) Subject to paragraph (2), between 1130 hours and 1600 hours on 25th and 26th August 2016, no aircraft is to fly below 5,500 feet above mean sea level within the area bounded by a circle having a radius of 3 nautical miles whose centre is at 514646N 0010837E.

(2) Paragraph (1) does not apply to any aircraft flying with the permission of the Clacton-on-Sea Air Show flying display director.

#### **EXPLANATORY NOTE**

#### (This note is not part of the Regulations)

These Regulations impose restrictions on flying in airspace specified in regulation 3(1) in the vicinity of Clacton-on-Sea, Essex during an air display for the general public that is scheduled to take place there on 25th and 26th August 2016. A large number of aircraft will be involved in high energy manoeuvres during the air show. Accordingly, the Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the air show during this period for reasons of public safety.

In relation to regulation 3, the term 'aircraft' includes aircraft as classified by Part A of Schedule 3 to the Air Navigation Order 2009. It also includes, by virtue of article 253(3) of that Order, any small balloon, any kite weighing not more than two kilograms, any small unmanned aircraft and any parachute including a parascending parachute.

The times mentioned in regulation 3(1) are Universal Co-ordinated Time (UTC), which for the purpose of these Regulations is one hour behind British Summer Time.
