# The Planning Act 2008 (Commencement No. 3) (England) Order 2017

*Made - - - - 7th November 2017* 

The Secretary of State makes this Order in exercise of the power conferred by section 241(8) of the Planning Act 2008(1):

#### Citation

1. This Order may be cited as the Planning Act 2008 (Commencement No. 3) (England) Order 2017.

#### Provisions coming into force on 1st January 2018 in relation to England only

- **2.** The following provisions of the Planning Act 2008 (so far as they are not yet in force) shall come into force, in relation to England only, on 1st January 2018—
  - (a) section 14(1)(m) (nationally significant infrastructure projects: the construction or alteration of a dam or reservoir);
  - (b) section 14(1)(n) (nationally significant infrastructure projects: development relating to the transfer of water resources);
  - (c) section 27 (dams and reservoirs); and
  - (d) section 28 (transfer of water resources).

#### **EXPLANATORY NOTE**

This Order brings into force provisions of the Planning Act 2008 which determine when development relating to the transfer of water resources or to the construction or alteration of a dam or reservoir will constitute a nationally significant infrastructure project for the purposes of the Planning Act 2008.
