**The Eggborough Gas Fired Generating
Station (Correction) Order 2018**

Made - - - - 6th December 2018

Coming into force - - 7th December 2018

The Eggborough Gas Fired Generating Station Order 2018 (“the Order”)(1), which granted development consent within the meaning of the Planning Act 2008 (“the Act”)(2), contains correctable errors within the meaning of the Act(3).

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(4) for the correction of errors in the Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed North Yorkshire County Council and Selby District Council, as the relevant local planning authorities(5), that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraphs 1(4) and 1(8) of Schedule 4 to the Act, makes the following Order:

Citation and commencement

1.—(1) This Order may be cited as the Eggborough Gas Fired Generating Station (Correction) Order 2018.

(2) This Order comes into force on 7th December 2018.
