The Air Navigation (Restriction of Flying) (Isle of Islay) Regulations 2018

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of the Isle of Islay, Argyll by reason of the intended holding of events to commemorate the centenary of the ending of World War I.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order $2016(\mathbf{a})$.

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Isle of Islay) Regulations 2018 and come into force on 4th May 2018.

Interpretation

2. In regulation 3 the times referred to are Co-ordinated Universal Time(**b**).

Restricted airspace

3.—(1) Subject to paragraph (3), between 0530 hours and 0930 hours on 4th May 2018 no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by a circle having a radius of 2 nautical miles whose centre is at 553527N 0062000W.

(2) Subject to paragraph (3), between 0630 hours and 1530 hours on 4th May 2018, no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by a circle having a radius of 2 nautical miles whose centre is at 553754N 0061131W.

(3) Paragraphs (1) and (2) do not apply to any aircraft flying in accordance with the permission of the Police Scotland Air Accidents and Incidents Advisor.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the airspace above the Isle of Islay, Argyll, during the holding of events relating to the centenary of the ending of World War I, that are scheduled to take place there on 4th May 2018. The Civil Aviation Authority and the Department for Transport agree that, at the request of Police Scotland, flying should be restricted in the vicinity of the event for reasons of security.

In relation to regulation 3 the term 'aircraft' includes aircraft as classified by Part 1 of Schedule 4 to the Air Navigation Order 2016. It also includes, by virtue of article 23 of that Order, any small balloon, any kite weighing not more than two kilograms, any small unmanned aircraft and any parachute including a parascending parachute.

The times mentioned in regulation 3 are Co-ordinated Universal Time (UTC), which for the purpose of these Regulations is one hour behind British Summer Time.
