The Air Navigation (Restriction of Flying) (Hylands Park, Essex) Regulations 2018

Made - - - - 4th June 2018

Coming into force - - 16th August 2018

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of Hylands Park, Essex by reason of the intended gathering of a large number of persons at the RiZE 2018 Concert which is scheduled to take place there.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Hylands Park, Essex) Regulations 2018 and come into force on 16th August 2018.

Interpretation

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time(**b**).

Restricted airspace

- 3.—(1) Subject to paragraph (2), between 0800 hours on 16th August and 1400 hours on 19th August 2018, no aircraft is to fly below 3,500 feet above mean sea level within the area bounded by a circle having a radius of 1.5 nautical miles whose centre is at 514246N 0002557E.
 - (2) Paragraph (1) does not apply to any aircraft—
 - (a) operated by or on behalf of the National Police Air Service,
 - (b) operated by or on behalf of the Helicopter Emergency Medical Service, or
 - (c) flying in accordance with the permission of the Festival Republic Silver Commander.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in airspace in the vicinity of Hylands Park, Essex, by reason of the RiZE 2018 Concert that is scheduled to take place there from 16th to 19th August 2018, inclusive. A large gathering of people will attend this event on each day and therefore the Civil Aviation Authority and the Department for Transport consider that flying should be restricted in the vicinity of the event for reasons of public safety.

In relation to regulation 3, the term 'aircraft' includes aircraft as classified by Part 1 of Schedule 4 to the Air Navigation Order 2016. It also includes, by virtue of article 23 of that Order, any small balloon, any kite weighing not more than two kilograms, any small unmanned aircraft and any parachute including a parascending parachute.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC), which for the purpose of these Regulations is one hour behind British Summer Time (BST).
