The Air Navigation (Restriction of Flying) (Balmoral) (Restricted Zone EG R704) Regulations 2019

Made - - - - 7th October 2019

Coming into force - - 16th May 2020

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of Balmoral, Royal Deeside, Aberdeenshire, having regard to the security considerations associated with this location by reason of it being the residence of members of the Royal Family.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Balmoral) (Restricted Zone EG R704) Regulations 2019 and come into force on 16th May 2020.

Interpretation

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time.

Restricted airspace

- **3.**—(1) Subject to paragraph (3), and in the restricted airspace mentioned in paragraph (2), no aircraft is to fly below 3,500 feet above mean sea level within the restricted airspace in the period beginning at—
 - (a) 0001 hours on 16th May 2020 and ending at 2359 hours on 2nd June 2020 and in the equivalent period in successive years, and
 - (b) 0001 hours on 10th July 2020 and ending at 2359 hours on 31st October 2020 and in the equivalent period in successive years.
 - (2) The restricted airspace mentioned in paragraph (1) is the area bounded by a circle having a radius of 1 nautical mile whose centre is at 570227N 0031349W.
 - (3) Regulation 3(1) does not apply to any aircraft—
 - (a) operated by or on behalf of—
 - (i) Police Scotland,
 - (ii) the Scottish Ambulance Service,

- (iii) the Maritime and Coastguard Agency for the purposes of a Search and Rescue operation, or
- (iv) The Queen's Helicopter Flight,
- (b) flying with the permission of the Police Scotland Royalty and VIP Planning North Unit or the Metropolitan Police, Royalty and Specialist Protection, or
- (c) either—
 - (i) operated by a member of the Royal Family, or
 - (ii) landing in the grounds of Balmoral at the invitation of the person in charge of the household there, provided that the Police Scotland Royalty and VIP Planning North Unit or the Metropolitan Police, Royalty and Specialist Protection has been informed in advance of such intended flight or landing.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of Balmoral, Royal Deeside, Aberdeenshire, in view of the need for security for the members of the Royal Family staying at, or visiting, Balmoral and at the request of the security services, the Secretary of State considers that it is in the public interest to restrict flying in the vicinity of that location.

In relation to regulation 3, the term 'aircraft' includes aircraft as classified by Part 1 of Schedule 4 to the Air Navigation Order 2016. It also includes, by virtue of article 23 of that Order, any small balloon, any kite weighing not more than two kilograms, any small unmanned aircraft and any parachute including a parascending parachute.
