# The Air Navigation (Restriction of Flying) (Swansea Bay) Regulations 2019

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of Swansea Bay, West Glamorgan, by reason of the intended holding of flying displays associated with The Wales Airshow 2019.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order  $2016(\mathbf{a})$ .

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Swansea Bay) Regulations 2019 and come into force on 5th July 2019.

#### Interpretation

**2.** In regulation 3(2) the times referred to are Co-ordinated Universal Time(**b**).

#### **Restricted airspace**

**3.**—(1) Subject to paragraph (3), and during the periods specified in paragraph (2), no aircraft is to fly below 8,000 feet above mean sea level within the area bounded by straight lines joining successively the following points—

- (a) 513800N 0040100W,
- (b) 513800N 0035100W,
- (c) 513400N 0035100W,
- (d) 513400N 0040100W, and
- (e) 513800N 0040100W.
- (2) The periods referred to in paragraph (1) are—
  - (a) between 1200 hours and 1600 hours on 5th July 2019, and
  - (b) between 1100 hours and 1600 hours on 6th and 7th July 2019.
- (3) Paragraph (1) does not apply to any aircraft flying in accordance with—

<sup>(</sup>b) In these Regulations Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

- (a) the permission of the Wales Airshow flying display director, or
- (b) the permission of Swansea Aerodrome air-ground service while in the Swansea Aerodrome Traffic Zone.

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in airspace in the vicinity of Swansea Bay, West Glamorgan, during air displays that are scheduled to take place there from 5th to 7th July 2019 (inclusive). A large number of aircraft will be involved in high energy manoeuvres during the displays and therefore the Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the displays for reasons of public safety.

In relation to regulation 3, the term 'aircraft' includes aircraft as classified by Part 1 of Schedule 4 to the Air Navigation Order 2016. It also includes, by virtue of article 23 of that Order, any small balloon, any kite weighing not more than two kilograms, any small unmanned aircraft and any parachute including a parascending parachute.

The times mentioned in regulation 3(2) are Co-ordinated Universal Time (UTC), which for the purpose of these Regulations is one hour behind British Summer Time (BST).

Full details of the Statutory Instrument will be promulgated by Aeronautical Information Circular (AIC) and Notice to Airmen (NOTAM).
