The Energy Information (Amendment) Regulations 2020

The Secretary of State makes these Regulations in exercise of the powers conferred by section 2(2) of the European Communities Act 1972⁽¹⁾.

The Secretary of State is a Minister designated⁽²⁾ for the purposes of section 2(2) of the European Communities Act 1972 in relation to the environmental aspects of product design.

Citation and commencement

1. These Regulations may be cited as the Energy Information (Amendment) Regulations 2020 and come into force on 23rd November 2020.

Amendment of the Energy Information Regulations 2011

2.—(1) The table set out in paragraph 1 of Schedule 1 (EU measures) to the Energy Information Regulations 2011⁽³⁾ is amended as follows.

EXPLANATORY NOTE

(This note is not part of the Regulations)

This instrument amends the Energy Information Regulations 2011 ([S.I. 2011/1524](#)) in relation to household combined washer-dryers, household washing machines, household dishwashers, household refrigerating appliances and electronic displays. It substitutes new Commission Delegated Regulations into the list of EU measures in Schedule 1 to the Energy Information Regulations 2011 which allows them to be enforced by the market surveillance authorities.

A full impact assessment has not been produced for this instrument as no, or no significant, impact on the private, voluntary or public sector is foreseen.
